Dress Code for Exemplification

It is the responsibility of the **Sponsor** and **Assembly** to make sure **Candidates** are informed and comply with the Dress Code.

Candidates are to be attired as follows: Black bow tie, plain white tuxedo shirt with straight collar,, black cummerbund, black footwear and black tuxedo.

Candidates who are in the Armed Forces, full time police and firefighters may wear their Class A dress uniform.

Fourth Degree members a jacket & tie are required. Social Regalia of Black bow tie, plain white tuxedo shirt with straight collar,, black cummerbund, black footwear, black tuxedo and social baldric worn under the coat, from right shoulder to left hip is recommended.

Ladies are encouraged to wear a dress, blouse/skirt, or pantsuit.
